All orders are accepted without liability for non-performance if labor shortages or delay in transportation should prevent us from making delivery.

BUYER'S sole and exclusive remedy against SELLER for breach of warranty, or breach of any statutory obligation or for negligence shall be for the replacement of the goods or for refund of the price actually paid. and grow, true-to-name, disease free and vigorous in growth when reasonable and proper care is given. We also guarantee to ship plants on or before confirmed dates. If for any reason you are not satisfied, notify us within two months after shipment. For claims received after June 30th, plants will be replaced the following spring. This guarantee covers full purchase price and does not imply any further responsibility or liability. Company reserves the right to charge shipping charges on large orders of replacement plants. Your satisfaction is our first concern at Indiana Berry & Plant Company.

ORDER DISCREPANCIES: Please contact us immediately upon receipt of your order for any discrepancies, damaged or missing items in your order. We opt to replace, refund or place a credit on your Indiana Berry account depending on the dollar amount of the items, no credit will be issued for less than \$2.00, and no refunds will be issued for less than \$5.00.

PHONE ORDERS: Please have your catalog available when placing your order as we will need specific codes from your mailing address on the back of the book. Also, please have your credit card (Mastercard, Visa, Discover) ready. A confirmation of your phone order will be sent within 24 hours from receipt of your phone call. If you do not wish to use your credit card you will have 15 days to mail your payment to us. If payment is not received within the 15 days your order will be cancelled without notice to you.
